

## BROADCAST LICENSE AGREEMENT FOR UNSIGNED ARTISTS

The ARTISTS named in the Broadcast License Agreement Acceptance Submission Form (hereinafter BLAASF) **do hereby consent to allow** THE RADIO GROTTO to **broadcast** the songs listed in the BLAASF. THE RADIO GROTTO shall determine if and when the songs shall be broadcast.

The ARTISTS named in the BLAASF **do hereby acknowledge to hold ALL of the rights** throughout the TERRITORY, including recorded performance rights and copyright, for the songs listed in the BLAASF. The ARTISTS named in the BLAASF **guarantee** that they own and control all rights. The ARTISTS named in the BLAASF **shall indemnify and hold THE RADIO GROTTO harmless** from any and all claims, liabilities and costs, losses, damages or expenses, including attorney's fees, arising out of any breach, allegation, claim or failure of any covenants or warranties made by the ARTISTS named in the BLAASF.

THE RADIO GROTTO **shall not have exclusive rights** to broadcast the songs listed by the ARTISTS named in the BLAASF. THE RADIO GROTTO shall credit on its Web site the ARTISTS or pseudonym or band name. The Broadcast License Agreement **may be revoked** by the ARTISTS, with or without cause, by email to [contact@radiogrotto.com](mailto:contact@radiogrotto.com).

ARTISTS may subsequently submit additional original songs to THE RADIO GROTTO without submitting a new BLAASF. By submitting the additional original songs, (1.) the ARTISTS do hereby declare they are the same ARTISTS listed in the initial BLAASF, and (2.) the ARTISTS do hereby agree to the Broadcast License Agreement for Unsigned Artists for the subsequently submitted songs.

This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same Agreement. The counterparts of this Agreement and all Ancillary Documents may be executed and delivered by facsimile or other electronic means such as an electronic submission form by any of the parties to any other party and the receiving party may rely on the receipt of such document so executed and delivered by facsimile or other electronic means such as an electronic submission form as if the original had been received.

### TERMS

The TERRITORY of this agreement is the entire universe.

The word UNSIGNED as used in this agreement means the ARTISTS named in the BLAASF have not been signed by a label or publisher and retain all rights to the submitted songs.

The word BROADCAST as used in this agreement means live and recorded broadcasts, including podcasts.

**THIS CONSTITUTES THE ENTIRE AGREEMENT BETWEEN THE PARTIES HEREIN.**
